4 New Features:

4.1 CYBER Program Status Code 764 – Family Planning Program

- The State of New Jersey, Department of Children and Families, Children’s System of Care (CSOC) has requested to make changes in CYBER to identify Medicaid Numbers with a Program Status Code (PSC) of 764 as “not valid” for CSOC services. The Insurance tab in CYBER displays third party liability and other insurance information gathered in CYBER and extracted from OIT and Molina. For this release CYBER will display Medicaid Number with a PSC of 764 as not valid for CSOC services.

The Program Status Code release will identify Medicaid segments with the associated PSC 764, flag it as not valid for CSOC services, and modify description and type information on the Insurance and Eligibility tabs within the youth record.

This includes:

- Identifying MAID segments with associated Program Status Code 764 and flag it as not valid for CSOC services.
- Modifying the type and description under Insurance tab.
- Modifying the Status Description under Eligibility tab.
- The Active TPL field on the Dashboard will be updated to display “No” if there is an active (no end date or future end dated) Medicaid Segments with PSC 764.

4.2 Assumptions

The following are the assumptions related to this release:

- Current Eligibility and Insurance functionality and process will remain the same except for the rules identified in section 4 Business Requirements.
- There are no impacts to Waivers.

5 Enhancements

The following enhancements are included in this release.
