4 New Features

4.1 Maintenance Release

The following changes have been made to CYBER regarding ability to request suspension of authorizations:

- Removal of the Authorization Detail Screen for CSA and CSOC Users.
- Addition of the following fields to display on the Add/Edit Authorization Screen
 - Authorization Number
 - Youth Medicaid ID number
 - New values added to the Decision drop down
 - New dropdown selection for Reason
- Security added to CSAFIN and CSAFINDIR for edit access to the add/edit Authorization Screen

The following changes have been made to CYBER Login Screen:

• A new link "Forgot Password?" for users to reset their passwords.

The following changes have been made to CYBER regarding the Eligibility Tab:

- All Non- EXE, CSAFIN and CSAFINDIR will no longer have access to the Medicaid Search functionality within the Eligibility tab in CYBER.
- A New security Group "MedIdAttach" for EXE, CSAFIN and CSAFINDIR for access to the Medicaid Search Functionality

The following changes have been made to CYBER regarding a new service code for MRSS/FCIU

• New CSA Service Code CSA55 will be added to the system

The following changes have been made to CYBER regarding FSO Security:

• FSO users will have the "Select a User" drop down added to their Welcome Pages

• FSOADM and FSOMGT security groups will able to view user activity (hierarchy).

The following changes have been made to CYBER regarding OAS ability to see Adolescent Housing Hubs (AHH) Provider Information Files (PIF's):

• OASCM security groups will now have view access to the AHH PIF's

4.2 FSS Respite Intake Assessment

The following changes have been made to CYBER regarding FSS Assessment Service Code:

- The new Service Code T1028HA will be added to the provider according to their Provider Type and Specialty
- The CSA will be able to create authorizations for the Respite Intake Assessment Service Code T1028HA
- FSS Providers will now receive a Respite Intake Assessment Authorization when the youth is admitted into the following types of Respite Services:
 - Agency After School Respite (AASR)
 - Agency Weekend Respite (AWR)
 - Agency Hired Respite (AHR)
 - Self-Hired Respite (SHR)
- FSS Providers will only receive the Respite Intake Assessment Authorization for "new" admissions.
- The Respite Intake Assessment Authorization will display on the Authorization on File Screen for FSS Providers.
- The FSS Welcome Page will be updated to include the Respite Intake Assessment Authorization under the following links:
 - o Current
 - o Last 30 Days
 - Expiring
 - Auth History
