4 New Features:

4.1 CYBER Cover All Kids System Scope

The following items will be updated in this release:

- Youth with an SPC 12 will be displayed on the youth's Eligibility tab on the Facesheet and the 3560 Application
- Special Program Code 12 description will be identified on the Eligibility Tab on the Youth Facesheet Special Program Grid
- Youth with an active SPC 12 are not eligible for the CSSP SED Waiver

4.2 Cover All Kids Assumptions

- The Medicaid Eligibility matching algorithm will not be updated, but may be evaluated at a later date for changes. Billing will manually attach eligibility when indicated.
- There is a checkbox on the 3560 Application Request – Approval tab, 'Do not add SPC 37', If this checkbox is selected, it will override the automated program used to determine whether the SPC 37 criteria is met and not add the SPC 37 to the 3560 and there is no change with this functionality
- The Dashboard will display the Medicaid # under Eligibility as per current rules.
- ASD Benefit CYBER functionality requires no updates and youth with an SPC 12 will be referred to their MCO for ASD services when conditions are met.
- As US Citizenship is required for DD Eligibility and DD Eligibility is required for the CSSP IDD Waiver and for Family Support Services, no changes will be made to the CSSP I/DD Waiver requirements or the FSS application process for the Cover All Kids program.
- No Changes are needed to modify the MLTSS tracking element flag in the system.
- The functionality to view Historical Progress Notes remains unchanged.
- Report NJ1561 Anomaly report identifies any youth with an SPC12 and MLTSS, CSSP SED, CSSP IDD, or Family Support Services via a subscription.

4.3 CYBER Project Connect System Scope

The following changes will be implemented in CYBER related to adding new values for Project Connect for CSA, CMO and MRSS users:

- New Caller Types Project Connect Hospital and Project Connect RCC (Regional Care Coordinator) will be added to the Call Module screen's Create Call tab
- New Call Reason PROJECT CONNECT will be added to the Call Module screen Create Call tab
- New value Referred by Project Connect will be added to the Referral Source drop-down selection in Add New Child to the system screen
- New value Referred by Project Connect will be added to the Referral Source drop-down selection in Demographics tab of Youth's Face Sheet
- New value Referred by Project Connect will be added to drop-down selection in Triage Form Demographics tab
- New Caller Types Project Connect Hospital and Project Connect RCC (Regional Care Coordinator) will be added to Triage Form Demographics tab
- New value Referred by Project Connect will be added to the Add/Edit Referral Source drop-down selection in Episode tab of Youth's Face Sheet for CMO and MRSS users

4.4 CYBER Project Connect Assumptions

- This change will apply to CSA, CMO and MRSS users
- The functionality to Add/Edit/View of Referral Source in Add New Child to the system, Episodes tab (CMO and MRSS users) and Demographics tab remains unchanged unless specified in the Business Requirements section of this document
- The functionality to Add/Edit/View 'Who referred you to call today?' and Caller Type drop-down selection within Triage Form Demographics tab remains unchanged unless specified in the Business Requirements section of this document
- The functionality of Call Module remains unchanged unless specified in the Business Requirements section of this document
