The following items were fixed and have been included in this release.

FB 26673 WO 256300	ISSUE: FSO user is unable to edit any FANS that were returned to her after she submitted them to a higher-level user at her agency. RESOLVED: The user's user id was created with a trailing space and this registered an issue during the return status for actual assignment. Dev as created a script to trim any leading or trailing whitespace from the user id field.
FB 26676 WO 256618	ISSUE: In cases of a previously mapped support entry, CSA users cannot End Date the support entry as the ACCEPT button is not active for use. RESOLVED: The area code was not present in some of the mapped Supports, but no validation was given showing the area code as the reason. The validation has been added to instruct users to make the needed correction.
FB 26954 WO 261082	ISSUE: An IIC user was unable to submit an IIC_2 plan as the LICENSE EXPIRATION DATE was flagging for any end date entered using the year 2021 or higher. RESOLVED: The standard set of validations has been enforced and the hardcoded '2020' end date year is no longer validated in error.
FB 26956 WO 261130	ISSUE: The STICKY NOTE text for the IIC_2's Matrix "Needs" child screen was not being displayed. RESOLVED: The full text, ""For youth who are 16 years of age and over, please clearly document how the youth is being prepared for self-sufficiency. This documentation
