# 4 Defect Fixes

The following items were fixed and have been included in this release.

FogBugz #/ Work Order #	Description
FB 20706 WO 175826	Issue: CSA Users cannot transfer Treatment Plans, Assessments or DD Eligibility Forms to another user. The User ID Dropdown on the Select User window is showing "PROJECTx.NJWebService.UsersForTreatmentPlanReview" where UserID's should appear.
WO 175833 WO 175832	Resolved: This issue has been resolved and CSA users are able to transfer documents to other CSA user as expected.
	Issue: When user tries to access submitted/Approved BSP plan - the PRINT warning message displays after clicking Ok - PRINT report never loads and throws an error.
FB 20707 WO 175834	Resolved: The length of an answer was too long which caused the whole report to crash. The length limits for answers has been adjusted to prevent the report from crashing.
	Issue: When a FSS users removes a zip code from their Programs PIF, FSS Applications are still being displayed in an Assigned status on their Provider Queues. After the batch was run the FSS Applications should have been changed to a Not Accept status.
FB 20689	Resolved: When a zip code has been removed from the FSS Providers PIF the FSS Applications that were matched to that Providers Queue because of the zip code are no longer displaying as expected.
	Issue: Demographic information entered on a youth's Facesheet is not being retained after the user saves the Demographic tab.
FB 20711 WO 175706	Resolved: The Demographic information entered on the youth's Facesheet is being saved and retained when the user clicks the Save button.
	Issue: The Eligibility grid on a youth's Facesheet Eligibility tab is missing columns when the search is being performed on the fields above the grid. The columns that are missing are Last Name, First Name, DOB, SSN.
FB 20709 WO 175871	Resolved: The Last Name, First Name, DOB, SSN columns now display in the Eligibility grid as expected.
ED 207021	Issue: Date fields on the Admissions tab are being sorted as strings rather than dates when the user sorts the grid. This causes the year not to be taken into consideration and when sorting dates in ascending order, dates in 2011 come before dates in 2010, etc. Per CYBER development standards, date fields should be sorted by date and not alphanumerically.
FB 207021 WO 176190	Resolved: Dates are now being sorted alphanumerically as expected.
	Issue: The Print for the Camp CABS is displaying "#Error" where the heading, YES/NO, and Comments should appear within the behavioral Risks section of the report.
FB 20742	Resolved: The headers reflect the correct information and no longer display #Error.
