

#### **CYBER 2.0 Post-Deployment Provider Sessions**

- <u>Care Management Organization</u> (CMO) tabular format for CMO plans, Strength and Needs
  Assessments (SNA) and Out of Home (OOH) referrals, Out of Home area with YouthLink, AHH Link,
  FSS Link, Provider Details.
- Family Support Organization (FSO) tabular format for FANS.
- Family Support Service (FSS) FSS Link, transfer process, reauthorization.
- <u>Intensive in Community</u> (IIC) tabular format for BPS assessment and IIC treatment plan, 1500 Health Insurance Claim Form.
- Intensive in Home (IIH) tabular format for IIH plans.
- <u>Individual Support Services</u> (ISS) tabular format for ISS plans, FBA assessments, BSP plans.
- <u>Intermediate Units</u> (IU) Face Sheet tabs including diagnosis and medications, doc upload, progress notes.
- <u>Mobile Response Stabilization Services</u> (MRSS) tabular format for MRSS plans and assessments, crisis tracking form, Out of Home, Provider Details.
- <u>Multisystemic Therapy</u> (MST) / <u>Family Functional Therapy</u> (FFT) / <u>Children's Crisis Intervention</u> <u>Systems</u> (CCIS), <u>Partial Hospital Provider</u> (PHP) – tabular format for Needs assessments.
- Out of Home (OOH) YouthLink, tabular format for OOH plans and assessments.
- <u>Security Administrators</u> enhancements to Manage Access.
- <u>Substance Use Treatment</u> (SUT) tabular SUT plans, Level of Care Index and SNA assessments.
