

The Children's System of Care offers Out of Home Treatment that provides 24 hour supervised, all-inclusive, co-occurring clinical services in a community-based setting for adolescents ages 13-18 who present with challenges in social, emotional, behavioral, and/or psychiatric functioning; as well as co-occurring substance use treatment needs. These services provide a treatment framework that integrates behavioral health and substance use clinical services that can be accessed through the county-based Care Management Organization (CMO).

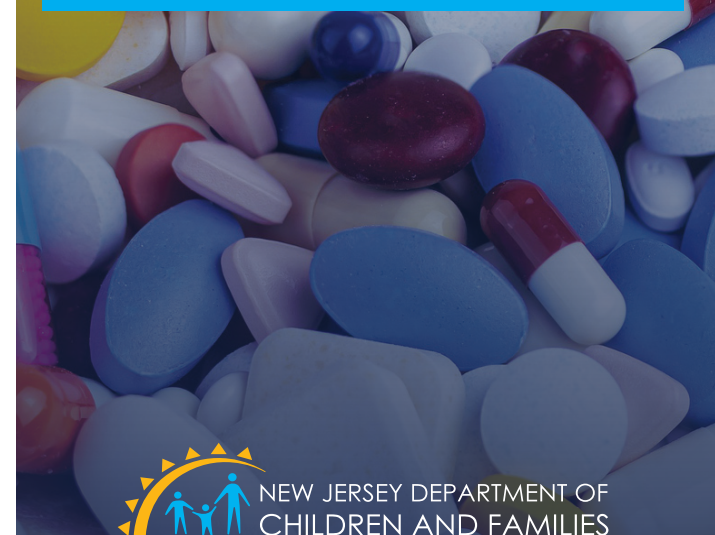

## **Accessing Services**

A parent/legal guardian may contact PerformCare to access CSOC contracted services. PerformCare's licensed clinicians complete assessments over the phone to provide referrals and appropriate authorizations for a variety of services.

Families may also access services directly through one of the CSOC contracted substance use treatment providers listed in this brochure. Providers will assist with linking the family to PerformCare. Access to PerformCare may also be facilitated by the Division of Child Protection and Permanency and the juvenile courts.

Service consideration for withdrawal management, short term residential and outpatient treatment is based upon the American Society of Addiction Medicine (ASAM) criteria. These decisions are made by Licensed Clinical Alcohol and Drug Counselors (LCADCs).

Services contracted with CSOC and authorized through PerformCare are made available without regard to income or health insurance.
